HAMBURG RAILFEST 2017

Plan now to come for the whole weekend: August 11-13. Ticket sales are expected to begin on March 15, 2017. RAILFEST will be celebrating the 50th anniversary of the Reading’s acquisition of locomotives #5308 and #6300, among the first locomotives to display the Reading Railroad’s *Bee Line Service* logo. Plans for the celebration include rail excursions, night photo session, photo contest, banquet featuring the editor of “Classic Trains” magazine, Robert McGonigal, a roundtable for former Reading Railroad employees, display of the amazing RCT&HS modular railroad (for the first time at RRHM), “Making a Bee Line” museum exhibit, activities for children, vendors, barbeque, music, and more. - Quotes are being obtained for the roof of the bus barn. Most of the failures in the roof are from old brittle plastic skylight panels. The quote will be for replacing the skylight panels with metal panels and repairing any

other leaks to make the building water tight.

- Wiring to the baggage car was complete and tested. Lights and heaters were tested and ok. Still to be completed is an outlet to power the adjacent LEMTU.
- Since the museum roof was replaced and seems to be water tight, all stained and damaged ceiling tiles in the museum store, restroom, lunch room, and business office were replaced.
- A contractor was called in to evaluate the air conditioner/heat pump in the "All Purpose Building". In spite of being without power for the past ten years, the HVAC Unit functioned ok. It will need a good cleaning, a new thermostat, and filters. We expect to be using the building this summer as a museum annex and a way to provide our visitors some relief from the heat.

TRAIN TRIP May 18th

The Pennsylvania Railroad Technical and Society, the Friends of the Railroad Museum of Pennsylvania, and the Reading Company Technical and Historical Society are jointly sponsoring a rail excursion from Sunbury to Yellow Hill with a stop in Shamokin. The trip will be on Thursday, May 18, 2017 with train departure at 9:30 a.m. Train boarding will start at 9:00 a.m. The route will go over former Pennsylvania Railroad trackage and former Reading Company

trackage that was used by ore trains in the 1940s and 1950s. The train consist will include a Pullman car, a baggage car, three restored coaches and a PRR N8 cabin car. 

